

Advocacy defined

ad·vo·ca·cy

public support for or recommendation of a particular cause or policy. "their advocacy of traditional family values" synonyms: support for, backing of, promotion of, championing of; More

- · the profession or work of a legal advocate.
- "Giving aid to or actively supporting a cause or position"
- Simply put...

Speaking out on your patient's behalf

- Problem that needs change, issue needs awareness, improvement in system
- Advocacy allows one to move from treating one patient at a time to being part of broader network

Advocacy Overview

- 4 levels of advocacy
- 1. Individual
- 2. Community
- 3. State
- 4. Federal





Individual Advocacy

- Direct care & resources provided to patients everyday
- Examples:
 - Calling insurance company, social service agency
 - Coordinating with another provider
 - Needed test or procedure



Individual Advocacy: Example


• Dr. Emma Somers, as PGY 2 Internal Medicine resident



- Patient with back pain, tried multiple pain medications, physical therapy, best relief from Lidoderm patches
- Lidoderm patches not covered by insurance, unless postherpetic neuralgia
- Called insurance company...denied
- Letter to insurance company...denied

Individual Advocacy: Example

- Visit with family, explains situation
- Patient's mother, "maybe you should call Joe Manchin"



- Speaks with staffer, tells patient's story
- Lidoderm approved, patient able to receive, patient & family grateful
- Experience + empathy + compassion + patient's story
 impacted decision

Community Advocacy

- Reaches beyond individual advocacy to affect those in your community, beyond those seen in the professional setting
- Takes into consideration the environmental and social factors influencing health
- Examples:
 - Health Fairs
 - School Health
 - Facing Poverty
 - Air & Water quality

State Advocacy

- Changing public policies, laws, and rules that impact health at state level
- Physicians use voice and credibility to advocate on behalf of public policies that impact patients
- Legislative, Governor's office, regulatory agencies
- Examples:
 - Substance Use Disorder
 - Immunizations
 - Changing HIV testing Policy (2011 SB 488)
 - Biologics Medication Access

Advocacy = Speaking out on your patient's behalf

Federal Advocacy

- Changing public policies, laws, and rules that impact health at federal level
- Physicians use voice and credibility to advocate on behalf of public policies that impact patients
- Legislative, Supreme Court
- Examples:
 - Access: ACA, AHCA, BCRA, Graham-Cassidy, CHIP
 - Payment for physicians, conditions, procedures
 - Nutrition: SNAP, WIC
 - Immigration, Women's Health, Environment, Substance Use Disorder, etc.

Making a Difference


- You don't have to be a legislative expert to impact decisions
- Decision-makers do not necessarily have health or medical backgrounds and need to hear from people who do.
- Opportune times to weigh-in:
 - during committee hearings
 - before key votes
 - during the budget process—when budget is being created by executive branch and when being adopted by legislative branch
 - before a bill reaches the governor's desk

Making a Difference

- Decision-makers that need to hear from you include:
 - your own decision-maker(s)
 - committee members and conference committee members
 - governors and other members of the executive branch
 - the public


